**Offence** Breach of Art. 14.1, 14.4 & 16.3 of the Clio Cup Series Sporting Regulations

**Decision** A drop of four positions on the starting grid for the next race in which the Driver will participate

**Reason** During the Dijon-Prenois Event, the Stewards received three reports from the Race Director concerning three different driving infringements (see details above).

After having summoned and heard the Driver Damiano PUCCETTI each time, after having examined all video evidence available and after due deliberation, the Stewards imposed the following decisions:

Decision No 3: best lap time deleted after Free Practice 1


Decision No 17: ten seconds time penalty added after Race 1


Decision No 28: drop of one position applied in the Race 2 classification

On 30 May 2025 the Stewards have summoned the Driver Damiano PUCCETTI to inform him about the present decision based on Article 16.3 of the Clio Cup Series Sporting Regulations.

The Stewards want to remind all Drivers that each penalty applied by the Stewards which is based on a driving infringement will result into one reprimand. Article 16.3 of the Clio Cup Sporting Regulations stipulates that any Driver who receives three reprimands for a driving infringement imposed by the Stewards during the 2025 season will, upon the imposition of the third reprimand, be given a drop of four positions on the starting grid at the following Race in which the concerned Driver will participate.
