The Stewards, having received a report from the Race Director (document 22) have considered the following matter and determine the following:

Driver 10 / POLDERMAN Stefan
Competitor POLDERMAN Stefan
Time 16:28
Session Race 2
Event Car 10 caused a collision with car 99 between turn 1 and turn 2
Offence Breach of Art. 14.1 of the Clio Cup Series Sporting Regulations
Decision A drop of 4 places on the starting grid for the next race in which the Driver will participate
In addition, 1 reprimand to be added to the Driver's record (Total for the 2025 season = 2 reprimands)
Reason The Stewards received a report from the Race Director (document 22).
The Stewards have examined the on-board video evidence of both cars.
The Stewards have summoned and heard from both Drivers together.
The Driver of car#99 explained that car#10 made a contact and then car#99 made a contact with car#4.
On his side the Driver of car#10 stated that it was a racing incident on his point of view.
Having considered the matter extensively, the Stewards determine that the Driver of car#10 was responsible for the collision. Furthermore, the Stewards agreed that this is a clear breach of the regulations and against the established driving standards.
Therefore, the Stewards considered this penalty as appropriate in that case.
This penalty has been taken in accordance of Article 14.4.g) of the Clio Cup Series Sporting Regulations.

Competitors are reminded that they have the right to appeal certain decision of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.

The Stewards, having received a report from the Race Director (document 21) have considered the following matter and determine the following:

Driver 1 / TORELLI Gabriele
Competitor TORELLI Gabriele

Session Race 2
Incident Car#1 left track and gained an advantage at turn#3
Offence Breach of Art. 24.3 of the Clio Cup Series Sporting Regulations
Non-compliance with Race Director's Briefing Notes (item 6.7, document 2)
Decision A drop of one place in the Race classification
In addition, 1 reprimand to be added to the Driver's record (Total for the 2025 season = 2 reprimands)
Reason The Stewards received a report from the Race Director (document 21).
The Stewards have summoned Drivers of cars#1 and #23.
The Stewards have examined video evidence and heard from both Drivers together but Mr Gabriele Torelli has already left the circuit. However, the Stewards have accepted to make the hearing remotely. The Driver of car#23 explained that he has been passed by car#1 outside the track limits and he has not given the position back. On his side Driver of car#1 admitted the mistake but according to him, it was not possible to give the position back at that moment.
Having considered the matter extensively, the Stewards agreed that this is a clear breach of the regulations and against the established driving standards.
Therefore, the Stewards considered this penalty as appropriate in that case.
This penalty has been taken in accordance of Article 14.4.j) of the Clio Cup Series Sporting Regulations.
